



## **BLARNEY ARMY MEMBERSHIP – Terms and Conditions (2022)**

These terms and conditions of membership (“Conditions”) apply to each Blarney Army™ member (“Member” and collectively “Members”). Please read these Conditions carefully to ensure that you understand and agree to them. If you do not agree to them, please let us know immediately (using the contact details below) and we shall remove you as a Member.

Becoming a Blarney Army™ member costs €40 per annum. Each individual person will only be entitled to one such membership.

The Blarney Army™ Membership is operated by Cricket Ireland (otherwise known as The Irish Cricket Union Company Limited by Guarantee). Cricket Ireland is the national governing body for cricket in the Republic of Ireland and Northern Ireland whose registered office is at 15c Kinsealy Business Park, Kinsealy, Co Dublin K36 YH61.

It is a condition of Blarney Army Membership that members comply (and procure that any ticket-holders comply) with these terms and conditions.

Nothing in these Conditions shall constitute or imply any guarantee of entitlement to a ticket or access to any cricket match.

If we amend these rules, any amendments will be published on the Blarney Army section of the Website so please check back regularly to see if there have been any updates. If we make any substantial changes, we may also email you if it's appropriate. It is your responsibility to check these Conditions for any such amendments.
